

SUPRA'S iBOX TRANSFER AGREEMENT

The terms used below are as used in the referenced Agreements.

The "Receiver" Keyholder as defined below acknowledges receipt of _____ Keybox(es) from "Transferor" Keyholder as defined below, the serial numbers of which are:

By signing below both the Transferring Keyholder ("Transferor") and Receiving Keyholder ("Receiver") agree that the transfer of the ownership of the above Keybox(es) from Transferor to Receiver will occur under the following conditions and terms:

1. Transferor and Receiver have both executed a valid "Keyholder Agreement" and a valid "Supra's iBox Purchase Agreement," both of which must be on file with M.L.S. of Naples, Inc. ("M.L.S."). Receiver must be a currently authorized Keyholder. If both agreements are not on file with M.L.S. or if Transferor and Receiver cannot produce a valid copy of both Agreements, then Transferor and Receiver must first execute any agreement that is not on file with M.L.S. or any agreement for which he cannot produce a valid copy as required for this "Supra's iBox Transfer Agreement" (the "Agreement") to be effective. In the event that Transferor is no longer an Authorized Keyholder, Transferor may execute this Agreement without satisfying the conditions in this Paragraph 1, but Transferor must have been an Authorized Keyholder at the time he or she acquired the Keyboxes being transferred pursuant to this Agreement. Receiver must satisfy all the conditions in this Paragraph 1.
2. Upon the transfer of any Keybox, Receiver will provide an executed copy of this Agreement to M.L.S. of Naples, Inc. before Receiver takes possession of the Keybox(s) but only if Paragraph 1 is satisfied. If the provisions in Paragraph 1 are not satisfied, Receiver and Transferor agree to satisfy them before executing this Agreement.
3. Receiver agrees to have M.L.S. of Naples, Inc. change the Keyboxes' Shackle Codes.
4. Both Transferor and Receiver agree that failure to comply with the above conditions will result in the deactivation of the non-complying Keyholder's Key or such other electronic device including certain cellular telephones and devices ("Device") as are approved by Supra for use in accessing Keyboxes until the situation is corrected to M.L.S. of Naples, Inc.'s satisfaction.

By signing this Agreement both Transferor and Receiver affirm that they have met the terms of this Agreement. Transferor and Receiver understand that this Agreement is not effective until dated and signed by the M.L.S. of Naples, Inc.'s Representative and that in the event this "Supra's iBox Transfer Agreement" is not signed and dated by the M.L.S.'s Representative, it is invalid for the purposes of transferring Keyboxes within the framework of the Supra's iBox System. **Failure to meet the terms of this provision will result in the deactivation of both Keyholders' Keys or Devices. In the event any information provided herein is found to be false or incorrect, the Keyholder's access to the Service who provided false or incorrect information will be deactivated until the situation is corrected to M.L.S. of Naples, Inc.'s satisfaction.**
